The Department is a full-service fire and emergency medical service agency that provides basic and advanced life support, fire prevention, fire suppression, technical rescue, and hazardous material response. 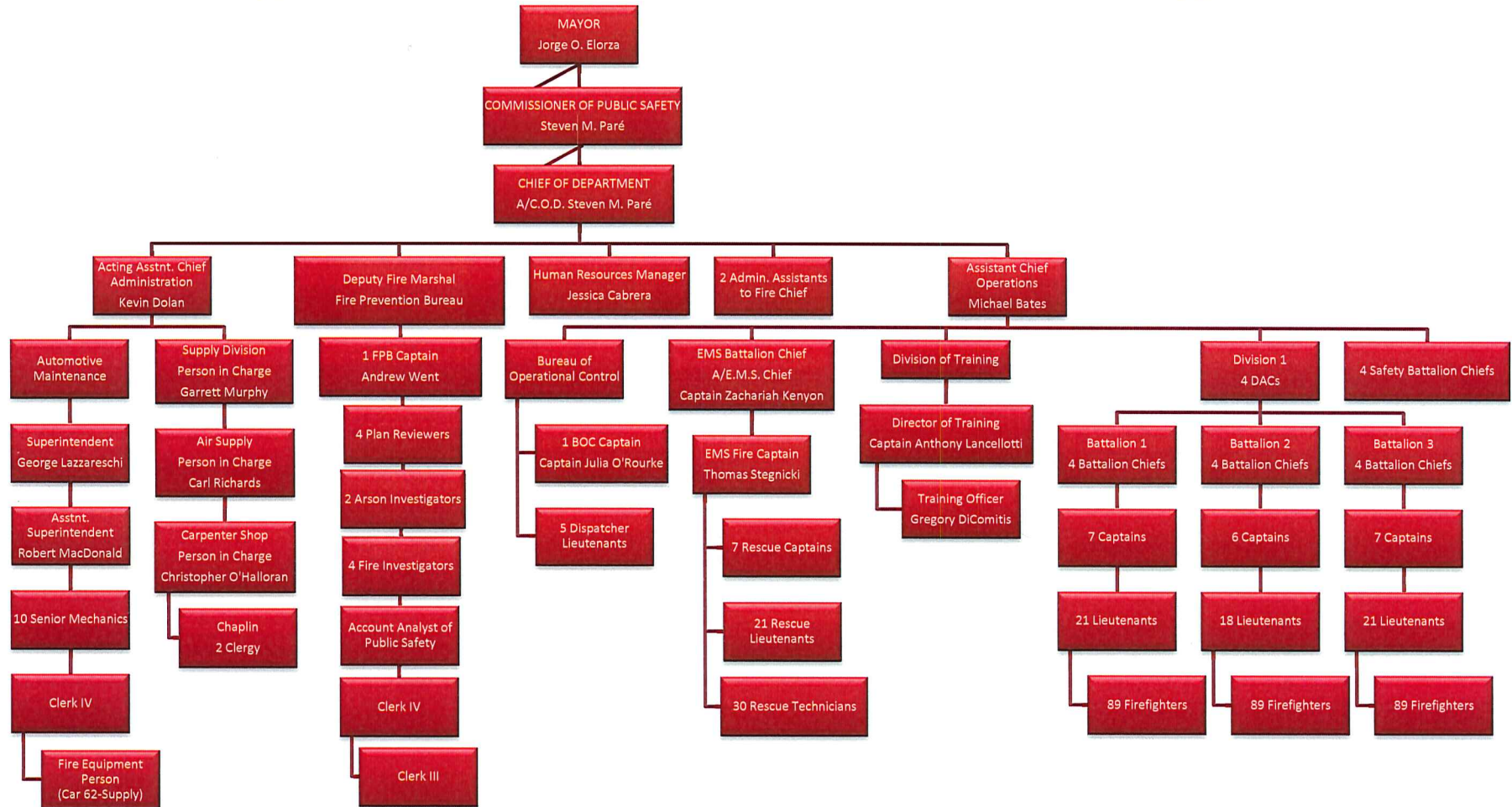

Providence Fire Department 2018 Annual Report

Established in 1854, the Providence Fire Department is the second oldest continuously operating professional fire department in the country. The Department is a full-service fire and emergency medical service agency that provides basic and advanced life support, fire prevention, fire suppression, technical rescue, and hazardous material response. In addition, the Department conducts arson investigations and building plan reviews, enforces state and local fire and life safety codes, and administers public fire education programs.

Accomplishments for 2018

In 2018, the Providence Fire Department responded to 45,475 total calls for service. Of the total calls, 34,468 or 75.8 % were emergency medical services related. The calls are composed of 26,472 advanced life support and 7,996 basic life support calls for service. In addition, the Fire Prevention Bureau's Arson Squad conducted 216 fire investigations. As always, Providence Firefighters answered calls with professionalism, compassion, and true to our mission to protect life and all property.

The following is a list of accomplishments that have been achieved through the dedication and hard work of all the members of the Providence Fire Department:

- The Department received Public Protection Classification I rating by the Insurance Services Office (ISO).
- The EMS Division began **Project Safe Stations** where an individual with a substance use disorder (SUD) can present themselves at any fire station and request entry into the program to begin the recovery process.
- The Department 52nd Training Academy began on June 4th, 2018 running for a period of twenty-four (24) weeks.
- The Department received 2017 Assistance to Firefighters (AFG) Grant in the amount of \$993,309 to train our members in NFPA 1521, 1041 and 1021 pro-board classes. Also this grant provided for wellness and fitness equipment.
- On November 21, 2018 seventy-three (73) recruits were sworn in as new firefighters. This was the most diverse graduating class in history of the department consisting of 35.6% minorities and 8 females.
- Equipped and trained four fire companies in active shooter and terrorist based responses. This is a joint operation with Providence Police Department.
- Continued the updates to the Department's Standard Operating Procedures and Rules and Regulations.

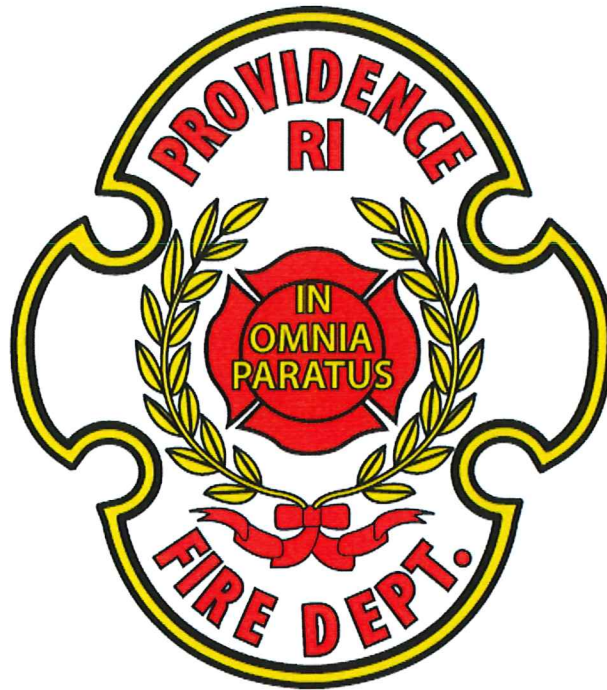

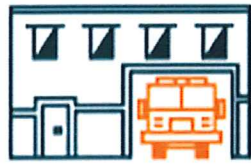

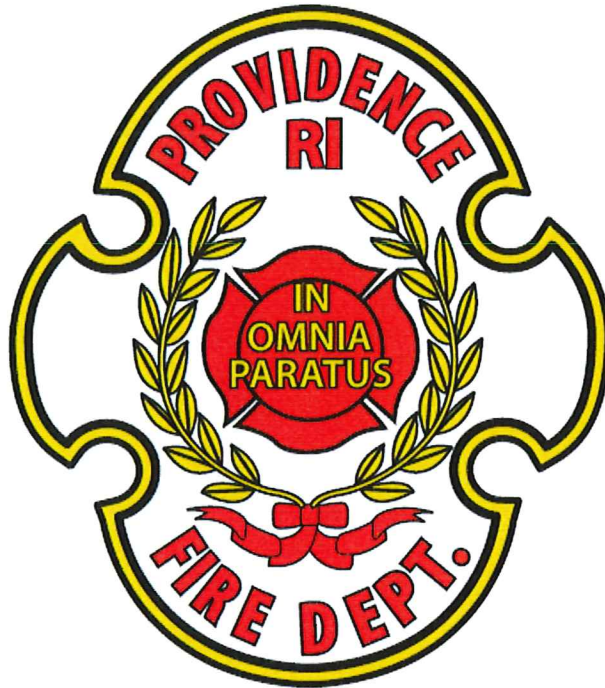

2018 Division of Training Activity

The Division of Training continues to provide the highest quality training, certification, and recertification services to the members of the Providence Fire Department. All fire department members continue with monthly and annual training which consists of structural firefighting training, hazardous material training, emergency medical training and continued education in numerous other areas so to prepare the members to handle different emergency responses on a daily basis. All training is either given at the Division of Training or in the Company's Stations.

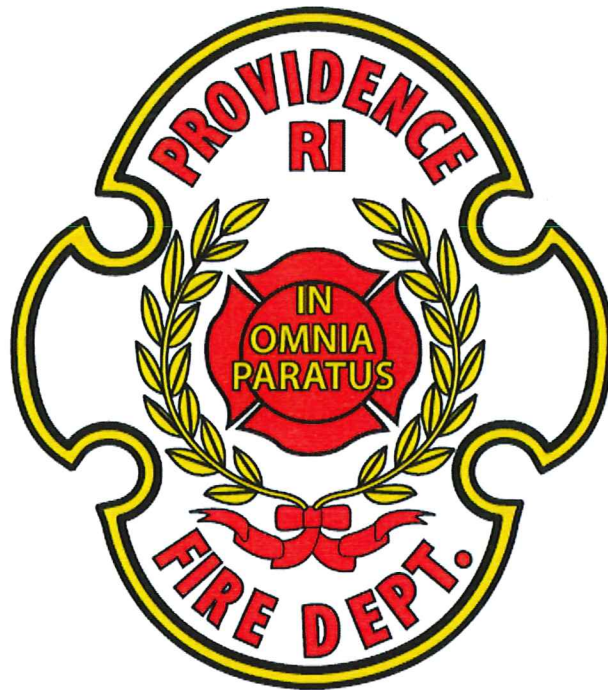

The Fire Prevention Bureau is a division of the Providence Fire Department. The primary responsibility of the Fire Prevention Bureau is to promote fire prevention and awareness which is essential to the department's overall mission. Some of the core functions of the Fire Prevention Bureau include plan review, code enforcement and inspections, public education, and fire investigations.

Plan Review

In April and May of 2018, the Fire Prevention Bureau transitioned to plan and payment intake exclusively through View Point Cloud software, accessible to the public through the City of Providence's website. Plans for new construction or renovation are reviewed for compliance with the Rhode Island Fire and Life Safety Codes, including fire rated construction, egress features, emergency lighting, and fire alarm and sprinkler systems. Throughout construction, Fire Prevention Bureau personnel make on-site inspections to ensure that as-built conditions reflect what was approved during the plan review process.

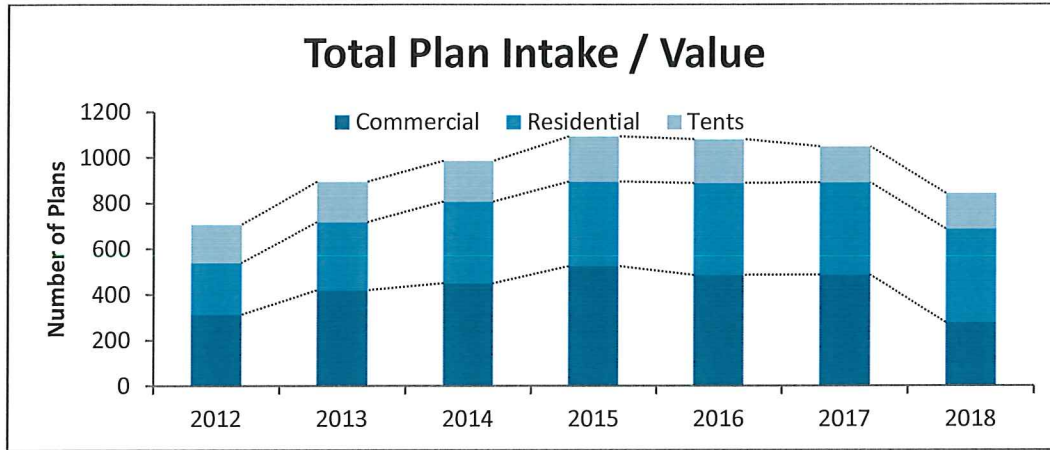

Fire and Life Safety Code Enforcement and Inspections

The Rhode Island Fire and Life Safety Codes require that certain occupancies be inspected on an annual basis. It places particular emphasis on the safe operation of certain occupancies, including nightclubs, places of assembly, schools, and apartment buildings. Additionally, Rhode Island law requires all residential properties to be inspected for smoke and carbon monoxide detection prior to their sale. The Fire Prevention Bureau also performs inspections at the request of the Providence Board of Licenses to ensure that establishments licensed for operation by the City are in compliance with the Fire and Life Safety Codes.

The Fire Prevention Bureau receives numerous complaints every year about potentially unsafe conditions and fire code violations. Each of these complaints is followed up on by a Fire Inspector, and sometimes involves coordination with other officials from the City's Code Enforcement Division. Mitigating complaints is crucial to preventing loss of life from fire and other hazards.

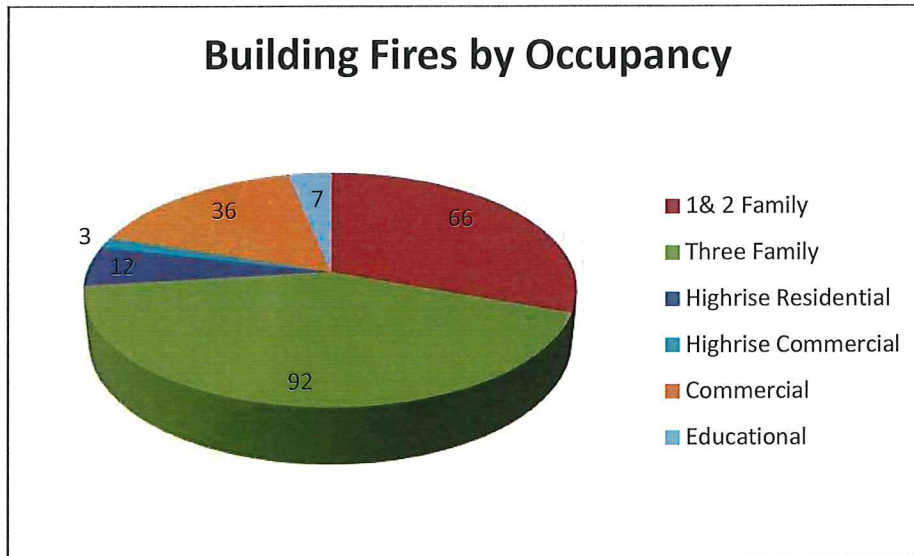

Fire Investigation

Providence Fire and Arson Investigators conducted 216 building fire investigations in 2018, 153 of which were classified as accidental, 40 as undetermined, 17 as incendiary, and 5 were the result of fires in other buildings. 170 of the fires were in residential structures, 39 in commercial buildings, and 7 in educational facilities.



Fire Investigators also investigated 98 vehicle fires, which included a street sweeper and an excavator, and 92 other fire incidents which included outside fires, trash fires, electrical shorts and overheated equipment and various other unsafe conditions. The Department's Arson Squad also investigated 22 burn injuries to citizens. Ten arrests were made by Arson Investigators.

Fires in Providence in 2018 resulted in an estimated dollar loss of nearly \$5 million for vehicles and structures.

Public Education

The Providence Fire Department participated in a wide range of formal public education and outreach activities in 2018. Education was presented through daycares, high-rises and apartment buildings, private and public schools, community organizations and events. At these events, members of the Fire Prevention Bureau distributed various educational materials, coloring books, and other fire safety messages. Fire apparatus were sent to 37 Touch-A-Truck events. In all, 102 separate events were held, reaching an estimated 8,185 members of the community.

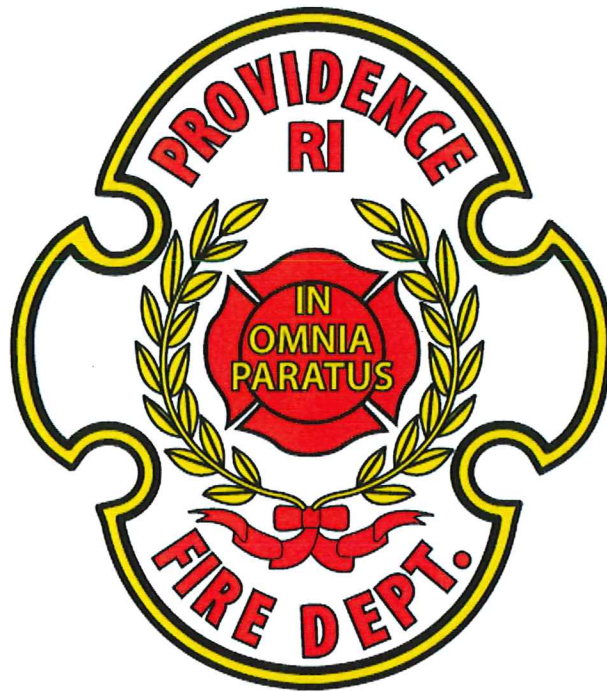

Free smoke and carbon monoxide alarms are available for distribution to those in need throughout the community from the Fire Prevention Bureau. In 2018, 105 smoke alarms and 52 carbon monoxide alarms were provided to residents of Providence.

Special Events and Fire Details

The Fire Prevention Bureau is involved with special event planning to safeguard the public and prevent dangerous situations. Personnel take part in bi-weekly city service meetings to plan for such events. In 2018, these included PVDfest, July 4th fireworks at India Point Park, WaterFire, and many other ethnic festivals, sporting events, and college events. The Fire Prevention Captain assigns uniformed firefighter details at places of assembly, special events, large events under tents, for hot work construction and other activities in accordance with the Rhode Island Fire and Life Safety Codes. Fire details ensure that all safeguards are in place and dangerous conditions do not exist. Fire alarm technicians are also assigned to details at certain venues when smoke or theatrical haze is in use to prevent disruption to shows or other business functions. In 2018, firefighters and alarm technicians covered a total of 2,435 details.
